Congratulations on Your New Sterling Home!

Mountains Edge Construction is the landscaping company hired to install your new home's landscape package from your home builder Sterling Homes. It is your responsibility as the homeowner to get in touch with us with by sending your **contact information** and **Landscape Package Certificate** so we can add your home to our installation schedule.

PLEASE NOTE: *We get very busy once the season gets into full swing and we suggest you contact us sooner rather than later to avoid delays or potentially having your hope skipped when we are installing in your community.*

In Order to Add Your Home to Our Schedule, Please:

6. Any other details relevant to your homes landscaping

More About the Process:

Many ask what they need to do to prepare for their landscaping install. He is a general overview of the process:

1. There is no preparation necessary. However, **WEED CONTROL** is the homeowner's responsibility. If weeds are present on the future lawn areas, they should be removed to avoid the weeds growing up through the new sod.
2. Once you have contacted us and have sent your contact details and landscape certificate, you will be added to our installation schedule. We will email with a 2-week window before the installation to give you an approximate idea of when we will start.

Once your installation date has arrived, Mountains Edge will:

3. Confirm and smooth out the grading of our yard with fresh screened loam.
4. Install any planting included in your package (shrubs and/or tree if listed on your certificate) – *Shrubs and Tree Permitted in the Front Yard only.***
5. The final step will be laying down the sod in the predetermined areas of your yard. *Sod is only permitted in the areas specified by Sterling Homes on your Certificate.***
6. Landscaping can occur over several days, with grading, loam, planting and the sod installation happening in stages.

***Placement of any plants/trees and the location of the sod are only permitted in the areas specified by Sterling Homes on your Certificate. We are only authorized to install the landscape package in the areas already designated by Sterling Homes. i.e. You cannot opt to move the sod included for your Front Yard to your Backyard.*
